1 Raffle Name

2 Promoter

The Tee Off MND 2023 Raffle will be conducted by Rock Off MND in support of Motor Neurone Disease Association of Victoria Inc. (ABN: 44 113 484 160) of 265 Canterbury Rd, Canterbury, Victoria. The benefiting organisation is Motor Neurone Disease Association of Victoria Inc., a not-for-profit organisation.

3 Permit Numbers

4 Relevant State(s)

Victoria (VIC), New South Wales (NSW), Queensland (QLD), Tasmania (TAS)

Note: Due to government regulations, WA and SA and ACT and NT residents are not permitted to purchase tickets in the raffle and are not eligible for any prizes.

5 Raffle Period

The Promotion starts at 9am AEDT on 1 October 2022.

The Promotion closes at 1.30pm AEDT on 19 February 2023.

No entries will be accepted after this time.

7 Maximum Number of Tickets

500 tickets available for purchase at \$100.00 each.

400 tickets are available for purchase online via RaffleTix. 100 tickets are available on paper for purchase from the raffle organiser.

The Raffle will close at the end of the Promotion Period or when all tickets are sold, whichever comes first.

8 Maximum Number of Entries

No maximum applies. Participants may purchase as many tickets as they like while the Raffle remains open and tickets are available.

9 Entry Restrictions

Entry is open to residents of VIC, NSW, QLD and TAS aged 18 years or older at the commencement of the Raffle.

Tickets cannot be purchased by any individual involved in the organisation of the raffle or the draw (including RaffleTix). In addition, tickets cannot be purchased by the association conducting or benefiting from the raffle, or its Management Committee including *immediate family members.

**Immediate family means a person's spouse and family members residing at the same premises as the person*

10 Verification Requirements

If requested by the Promoter, a person drawn as the winner of a prize must produce proof of age and residency prior to being awarded a prize. If they do not do this promptly to the reasonable satisfaction of the Promoter, the Promoter may redraw the prize subject to the relevant regulatory approvals, in which case that person forfeits any right to claim the prize.
