## Privacy policy

The National Police Memorial as Trustee for the National Police Foundation (NPF) is a Trust with Public Ancillary Fund Status established to provide assistance to the spouse, children and other dependents of police officers killed, disabled or otherwise injured in the line of duty. The Wall to Wall Ride for Remembrance is an annual event established for the purpose of raising funds for donation to Police Legacies in each State and Territory of Australia as well as to promote safe and lawful motorcycle riding and to pay tribute to fallen colleagues. Through this event, the NPF gathers information from participants and other people partaking in fundraising activities. NPF understands individuals' concerns regarding confidentiality and takes seriously its obligations in respect of all information it gathers. NPF is committed to being consistent to both its mission and the laws of Australia. It therefore seeks to abide by the *Privacy Act 1988*.

#### **Privacy policy framework**

This framework ensures the organisation including all its employees, volunteers with office bearing positions, sectors and activities collect, use, hold, correct and disclose personal information in a manner that conforms to the amended *Privacy Act 1988*.

## **Privacy policy**

All personal information collected by all sectors of the National Police Memorial as Trustee for the National Police Foundation (NPF) will comply with the National Privacy Principles as detailed below and as amended from time to time.

#### How and why we collect personal information

- a) Nature of information:
- The information we collect in most cases relates to participants, friends and families of Wall to Wall Ride participants but can relate to suppliers and other parties with which we deal.
- Personal Information is gathered for a range of purposes, including: the provision of information; fundraising activities and provision of event riders packs.
- In this policy 'personal information' means any information or opinion about an individual from which her/his identity is apparent or can reasonably be ascertained.
- b) Collection of information:
- Personal information is collected directly from you when you provide this information in the registration process on the Wall to Wall Ride website or in documents such as raffle tickets.
- When personal information is collected from you, you will be advised at the time of collection or as soon as practical after its collection as to: the purpose of collection and the fact that you can gain access to the Personal Information.
- c) Sensitive information:
- A third party company (GoFundraise Pty Ltd) has been engaged for the purposes of collecting financial donations / registration fees and therefore no financial or credit card information is collected by the NPF.

#### What we do with your information

In general only volunteers with office - bearing positions or the Company Secretary / Office Manager, or appointed Event Manager may view your personal information. Your personal information will not be shared with any party or company other than the NPF.

NPF will only disclose personal information to parties other than our volunteers with office bearing positions and the NPF Secretariat if: that disclosure is required to give effect to the purpose for which we collected the Personal Information; you have consented to that disclosure; we believe that the disclosure may lessen a risk of harm to the health or safety of any person; we believe that unlawful activity is being undertaken and Personal Information is disclosed as part of our investigation into this activity; we are required by law to disclose this activity; the disclosure is required for the enforcement of a criminal law or a law imposing a pecuniary penalty or for the protection of public revenue; or the third party is NPF's agent or contractor and is required by us to keep that personal information confidential and will only use that information for the purpose for which it is disclosed.

### Quality and security of personal information

We will take reasonable steps to ensure that personal information is accurate and provide opportunities for individuals to update their personal information.

Personal Information is stored on computer. Reasonable steps will be taken to ensure that personal information stored on computers are secure.

We regularly delete, destroy or de-identify personal information if the information is no longer needed by us.

#### How to access and correct your personal information

Where NPF does withhold personal information, we may instead choose to give you a summary of that information.

## Identifiers

NPF does not use any prohibited identifiers (for example tax file or health care card numbers).

## Transborder data flows

NPF will not transfer personal information overseas.
