

# Pioneers Major Lottery 2024

## Terms and Conditions

### 1.1.1 Promoter

**Pioneers Major Lottery 2024** will be conducted by Pioneers Basketball Club Incorporated ABN 99 303 085 691. The benefitting organisation is Pioneers Basketball Club Incorporated. The benefitting organisation is a not-for-profit organisation.

### 1.1.2 Promotion Period

The Raffle starts at 9am ACT on Friday, 21 June 2024. The Raffle closes at 5pm ACT on Monday, 14 October 2024. No entries will be accepted after this time.

### 1.1.3 Raffle Website

### 1.1.4 Relevant States

Entry is open to residents of the following States/Territories aged 18 years or older at the commencement of the Raffle:

- South Australia (SA)

Residents of any other States and Territories not listed above are not permitted to enter the raffle and are not eligible for any prizes.

### 1.1.5 Maximum Number of Tickets

5,000 tickets are available for purchase. The following ticket pricing bundles are offered:

1 tickets for \$20

2 tickets for \$40

3 tickets for \$60

4 tickets for \$80

6 tickets for \$100

15 tickets for \$250

30 tickets for \$500

60 tickets for \$1,000

300 tickets for \$5,000

The Raffle will close at the end of the Promotion Period or when all tickets are sold, whichever comes first.

#### 1.1.6 Maximum Number of Entries

No maximum applies. Participants may purchase as many tickets as they like while the Raffle remains open, and tickets are available.

#### 1.1.7 Entry Restrictions

Entry is open to residents of the **Relevant State(s)** aged 18 years or older at the commencement of the Raffle.

The following people are not eligible to enter and are not eligible for any prizes:

- Members of the Management Committee from the Organisation conducting the raffle or benefitting from the raffle;
- Employees and Contractors of RaffleTix;
- Any other person directly engaged in managing the raffle or conducting the draw; or

The following entities are not eligible to enter and are not eligible for any prizes:

- The Organisation conducting the raffle;
- The Organisation benefiting from the raffle.

#### 1.1.8 Verification Requirements

If requested by the Promoter, a person drawn as the winner of a prize must produce proof of age and residency prior to being awarded a prize. If they do not do this promptly to the reasonable satisfaction of the Promoter, the Promoter may redraw the prize subject to the relevant regulatory approvals, in which case that person forfeits any right to claim the prize.

#### 1.1.9 The Prizes

#### 1.1.10 Draw Details

The Draw will take place at 5.15pm ACT on Monday, 14 October 2024 at Carlin & Gazzard, 116-138 Commercial Street East, Mount Gambier SA 5290.

The draw will take place in accordance with State Government regulations. The draw will be conducted by the Promoter.

## **Draw Method**

A manual draw will be conducted. First prize will be drawn first followed by all other prizes in descending order.

### **1.1.11 Notification and Publication of Winners**

Winner will be contacted by phone and email within 3 business days of being drawn, by Thursday, 17 October 2024. Prize winners' name will be published on the Raffle Website and the Pioneers Basketball Club website and Facebook pages, and the SE Voice by Thursday, 17 October 2024.

### **1.1.12 Prize Claim Date**

Winners have 12 months from the date they are notified in which to claim their prize unless the winner resides in ACT (if eligible).

### **1.1.13 Unclaimed Prize Arrangements**

If a Prize is not claimed by the Prize Claim Date or is deemed invalid in accordance with the Entry Restrictions a redraw will occur. In the event of a Dispute, the raffle Promoter will attempt to resolve the dispute directly with the Complainant. If a satisfactory outcome between the parties is unable to be achieved, the Promoter will liaise directly with the relevant State and Territory Authorities.
