Promotion Period: The Promotion starts at 9am AEST, on Monday, 9 November 2020. The Promotion closes at 10am AEST on Monday, 7 December 2020. No entries will be accepted after this time.

Relevant State(s): Australian Capital Territory, New South Wales and Queensland

Entry Restrictions: Entry is open to residents of Australian Capital Territory, New South Wales, and Queensland, aged 18 years or older at the commencement of the Promotion. Excluding employees of the Raiders Trading Group, including but not limited to Canberra District Rugby League Football Club, Canberra Raiders Pty Ltd, Queanbeyan Leagues Club and their immediate families ("Eligible Entrants"). Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
