Promoter

The **Camberwell Girls Grammar School Gall Ball Raffle** will be conducted by **Camberwell Girls Grammar School (the School)**. The benefitting organisation is Camberwell Girls Grammar School, 79 004 166 349, a not-for-profit organisation.

Raffle Promotion Period

The Raffle starts on Wednesday May 28.

The Raffle closes at 9.00pm on Saturday June 21. No entries will be accepted after this time.

Relevant States

Entry is open to residents of the following States/Territories aged 18 years or older at the commencement of the Raffle:

- a. Victoria (VIC)

Residents of any other State and Territory not listed above are **NOT PERMITTED** to purchase tickets in the raffle and are not eligible for any prizes.

Entry Restrictions

The following people are not eligible to enter and are not eligible for any prizes:

- a. The Principal, The Chief Financial & Operating Officer, The Director of Development, and the Engagement and Marketing Team from the Organisation conducting the raffle or benefitting from the raffle;
- b. Employees and Contractors of RaffleTix;
- c. Any other person directly engaged in managing the raffle or conducting the draw; or
- d. Any immediate family members of any of the above. Immediate family means a person's spouse (including de-facto spouse), parents, children, and any other family members residing at the same premises as the person.

The following entities are not eligible to enter and are not eligible for any prizes:

- e. The Organisation conducting the raffle;
- f. The Organisation benefitting from the raffle.

Verification Requirements

If requested by the Promoter, a person drawn as the winner of a prize must produce proof of age and residency prior to being awarded a prize. If they do not do this promptly to the reasonable satisfaction of the Promoter, the Promoter may redraw the prize subject to the relevant regulatory approvals, in which case that person forfeits any right to claim the prize.

Maximum Number of Tickets

1500 tickets are available for purchase.

The ticket price options can be seen under the **Buy Tickets** section on the raffle website.

Maximum Number of Entries

No maximum applies. Participants may purchase as many tickets as they like while the Raffle remains open, and tickets are available.

As the organiser of the raffle, the School reserves the right to cancel the raffle and refund tickets if a minimum of 400 ticket sales is not achieved.

Prize Details

The prizes, including all relevant Terms and Conditions relating to the prizes, can be seen under the **Prizes** heading on the raffle website.

Prize values are accurate as at the commencement date for the Raffle. All costs, fees, charges, or expenses associated with the Prize(s), which are not specified, are the responsibility of the Winner(s).

- i. Prizes are not transferable, exchangeable, or redeemable for cash.
- ii. There will be two individual prizes with each prize being to the value of \$8000 credit towards the 2026 tuition fees. For new 2026 enrolments, the credit can only be applied from Term 2, 2026.
- iii. The prize does not include or cannot be applied to any supplementary charges to the school account such as the composite fee, excursions, levies, voluntary building fund or any other items which may be included on the school account.
- iv. The prize is not redeemable for cash or for credit application in any year other than the 2026 school year.
- v. The prize is not transferable to any other person or 3rd party other than the person nominated on the ticket purchased.
- vi. The prize may not be on-sold or auctioned or similar to another person or persons.
- vii. The prize is to be used for one student nominated by the parent.
- viii. Alternatively, two individual prizes, both to the value of an \$8000 travel voucher plus a Purple Ribbon Service Fee to the value of \$500 will also be available to winning participants in lieu of the \$8000 credit towards 2026 tuition fees where such persons do not have a child enrolled at Camberwell Girls Grammar in 2026.

The Purple Ribbon Service Fee to the value of \$500 which is an additional part of this voucher is only available from the above office of Ashmore, Harris and James Travel Associates.

Draw Details

The draw will take place at 10pm on Saturday June 21 at Leonda, 2 Wallen Rd, Hawthorn.

The draw will take place in accordance with State Government regulations. The draw will be conducted by the Promoter.

Draw Method

The draw will be conducted by a live electronic draw at the Gala Ball held at Leonda. The names of the purchasers of the winning tickets will be displayed on the screen at the Gala Ball at this time.

Notification and Publication of Winners

The winners will be notified in writing, and the names of the winners may be published on the School's Website, social media accounts, Principal's News and Cam Life.

The School may use a prize-winner's details for promotional purposes. By purchasing a Raffle ticket, they agree to participate in reasonable media activities concerning the Raffle draw and to photographs or video of the winner being used for School marketing and promotional activities (both in print and on the internet).

Prize Claim Process

- i. The winners, after receiving notification from the School by letter, are required within thirty days of the drawing of the Raffle to notify the School of their intention to claim their Prize (School Fees Credit for 2026 or Travel Voucher).
- ii. If it is the intention of the winners to claim School Fees Credit, the winner will need to indicate to the School in writing, an acceptance of this prize. In the case of the winner having multiple children attending the School, they will need to inform the School as to which child's tuition fees, the credit should be applied to.
- iii. If it is the intention of the winners to claim the Travel Voucher as their prize (subject to conditions as indicated above as regards to eligibility), the winner will need to indicate to the School in writing of their acceptance of this prize. The School will organise for the winners and the representatives from Travel Associates to attend the School in an appropriate timeframe to physically transfer the Travel Voucher to the winner in person.

Dispute Resolution

In the event of a dispute, the raffle Promoter will attempt to resolve the dispute directly with the Complainant. If a satisfactory outcome between the parties is unable to be achieved, the Promoter will liaise directly with the relevant State Authorities.
