1 Raffle Name

2 Promoter

5 Raffle Period

The Promotion closes at 11.59pm AEST on 8 October 2021.

No entries will be accepted after this time.

7 Maximum Number of Tickets

5300 tickets available for purchase at \$50.00 each.

The Raffle will close at end of the Promotion Period or when all tickets are sold.

8 Maximum Number of Entries

No maximum applies. Participants may purchase as many tickets as they like while the Raffle remains open and tickets are available.

9 Entry Restrictions

Entry is open to residents of NSW, VIC, SA, TAS and NT, aged 18 years or older at the commencement of the Raffle.

Directors, management, employees, contactors (or members of their immediate family) of the Promoter or the Promoter's related entities or any of the Promoter's agents, including RaffleTix, (as determined by the Promoter) are not eligible to enter.
