## 5 Raffle Period

The Promotion closes at 11pm on 05/07/2021 AEDT. No entries will be accepted after this time.

## 7 Maximum Number of Tickets

4,000 tickets available for purchase at \$25 each.

## 8 Entry Restrictions

Entry is open to residents of New South Wales, Victoria, Australian Capital Territory, Queensland, South Australia, Tasmania and Northern Territory aged 18 years or older at the commencement of the Raffle.

Directors, management, employees, contactors (or members of their immediate family) of the Promoter or the Promoter's related entities or any of the Promoter's agents, including RaffleTix, directly involved in the organisation of the Raffle (as determined by the Promoter) are not eligible to enter.
