## 4 Relevant State(s)

Australian Capital Territory (ACT) and New South Wales (NSW)

**Note**: Due to government regulations, residents of Queensland (QLD), South Australia (SA), Northern Territory (NT), Western Australia (WA) and Tasmania (TAS) are not permitted to purchase tickets in the raffle and are not eligible for any prizes.

## 8 Maximum Number of Entries

## 9 Entry Restrictions

Entry is open to residents of Australian Capital Territory (ACT) and New South Wales (NSW) aged 18 years or older at the commencement of the Raffle.

Tickets cannot be purchased by any individual involved in the organisation of the raffle or the draw (including RaffleTix). In addition, tickets cannot be purchased by the association conducting or benefiting from the raffle, or its Management Committee including \*immediate family members.

\*Immediate family means a person's spouse and family members residing at the same premises as the person

# 10 Verification Requirements
