The main draw will be held on Wednesday, 27th April 2022 at 11am AEST in accordance with State Government legislation.

PRIZE DETAILS

TOTAL PRIZE VALUE: \$25,000 in Cash

Information on how to enter and details of prizes form part of these Terms. Entry into the lottery and/or draw(s) detailed below is deemed acceptance of these Terms and entrants warrant that they are not prohibited from accepting a prize. The person who has purchased the winning ticket will provide to the LifeFlight Foundation representative, a current bank account number, to facilitate the transfer of funds directly into their account.

The lottery is run by LifeFlight Foundation ABN 636 1817 0184 of 160 Robina Town Centre Dr, Robina QLD 4226.

Entries are open to residents of Queensland and NSW who are 18 years of age or older and who are not ineligible for entry.

The following persons are ineligible for entry:

- A member of the LifeFlight Foundation management committee including:
 - LifeFlight Foundation Board and executive management
 - LifeFlight Australia Board and executive management,
- LifeFlight Foundation Employees
- all other parties (their employees or agents) associated with data access in connection with administration of the draw; and
- immediate family members of persons identified in paragraph (a) and (b) above including spouses; de facto spouses; parents; siblings; half-siblings; and children.

It is the responsibility of all persons who enter the lottery to ensure they are eligible under all applicable laws to accept the prizes offered as part of the lottery.

All entries received and processed prior to the closing time are automatically entered into the relevant lottery. Only Australian currency is accepted as payment for an entry.

All prizes will be drawn at LifeFlight Foundation LifeFlight Australia offices, 160 Robina Town Centre Dr, Robina QLD 4226.

Winning ticket numbers and winners' details are validated against records held in our database and all decisions of the Promoter are final. Where LifeFlight Foundation is unable to contact a winner or any prize remains unclaimed the requirements of the State/territory legislation will be followed.
