

# Terms and Conditions

### 1. Raffle Name

### 2. Promoter

New South Wales (NSW), Queensland (QLD), Victoria (VIC), Australian Capital Territory (ACT), Northern Territory (NT).

### 5. Raffle Period

The Promotion starts at 9am AEDT on Thursday 1st December 2022.

The Promotion closes at 9am AEDT on Tuesday 28th February 2023. No entries will be accepted after this time.

#### 8. Maximum Number of Entries
