

# ***Water Polo Australia Raffle Olympic Games Paris 2024 Hospitality and Travel Packages***

## Terms and Conditions

### 1 Raffle Name

Water Polo Australia Raffle: Olympic Games Paris 2024 Hospitality and Travel Packages

Note: There will be **three raffles** in the series:

- Raffle #1
- Raffle #2 (Cancelled)
- Raffle #3

Each raffle will be conducted as a separate raffle event that requires separate entry.

### Promoter

The Water Polo Australia Raffle: Olympic Games Paris 2024 Hospitality and Travel Packages (Raffle #1, Raffle #2 -Cancelled, Raffle #3) will be conducted by Water Polo Australia Limited (WPA), ABN: 86 159 573 403, of Accor Stadium, Level 3 East, Edwin Flack Avenue, Sydney Olympic Park, NSW 2127.

The benefiting organisation is Water Polo Australia a not-for-profit organisation and the proceeds will be used to support the Australian Water Polo teams and the athletes and the Australian Water Polo League Clubs with ongoing cost of training and competition.

### 3 Relevant State(s)

#### Permitted

Entry is open to residents of the following State(s) aged 18 years or older at the commencement of the Raffle:

- Australian Capital Territory (ACT)
- New South Wales (NSW)
- Northern Territory (NT) – Available for Raffle #1 and Raffle #2 (Cancelled) only. Due to recent changes in regulations not available for Raffle #3
- Queensland (QLD) – tickets limited to a maximum of 2,500
- South Australia (SA)
- Tasmania (TAS)
- Victoria (VIC)

#### Not Permitted

Residents of the following States are **NOT PERMITTED** to purchase tickets in the raffle and are not eligible for any prizes:

- Western Australia (WA)

The Raffles will close at the end of the Promotion Period or when all tickets are sold, whichever comes first.

## 7 Maximum Number of Entries

No maximum applies. Participants may purchase as many tickets as they like while the Raffle remains open, and tickets are available.

## 8 Entry Restrictions

Entry is open to residents of the **Relevant State(s)** aged 18 years or older at the commencement of the Raffle.

Tickets cannot be purchased by any individual involved in the organisation of the raffle or the draw (including RaffleTix). In addition, tickets cannot be purchased by the association conducting or benefiting from the raffle, or its Management Committee including immediate family members\*.

*\*Immediate family means a person's spouse and family members residing at the same premises as the person*

## 9 Verification Requirements

If requested by the Promoter, a person drawn as the winner of a prize must produce proof of age and residency prior to being awarded a prize. If they do not do this promptly to the reasonable satisfaction of the Promoter, the Promoter may redraw the prize subject to the relevant regulatory approvals, in which case that person forfeits any right to claim the prize.

The draws will take place in accordance with State Government regulations. The draws will be conducted by the Promoter.

Draw method: An electronic draw will be conducted. First and only prize will be drawn first.

## 11 Prize Details

For each raffle there is one prize only.

Prize values are accurate as at the commencement date for the Raffle. All costs, fees, charges, or expenses associated with the Prize(s), which are not specified, are the responsibility of the Winner(s).

Prizes are not transferable, exchangeable, or redeemable for cash. If for any reason a prize is not available, the Promoter will substitute it for another prize of equal or higher value (at the Promoter's absolute discretion), subject to regulatory approval.

## 12 Total Prize Pool

The Total Prize Pool value for each raffle is: AUD\$25,000.

## 13 Notification and Publication of Winners

Winners will be notified by telephone and in writing within 3 business days of being drawn (by Wednesday, 8 May 2024). Prize Winners' names will be published on the Raffle Website and the Water Polo Australia website and Facebook pages.

## 14 Prize Claim Date

Due the nature of the prize i.e.: Travel Prize with specific dates to a specific event, Winners have one (1) month from the date they are notified in which to claim their prize.

If the winner resides in the ACT and they do not claim their prize by one (1) month after the applicable Raffle draw, a redraw/unclaimed prize draw will be held in the same manner as the original draw three (3) days after claim date, at Accor Stadium, Level 3 East, Edwin Flack Avenue, Sydney Olympic Park, NSW 2127. If the redraw winner does not claim their Prize within one (1) month from the date, they are notified in which to claim their prize, the Promoter reserves the right (subject to regulatory approval, if required) to sell that prize.

Winners are to contact the **Promoter** to claim their prize.

If you are a Winner, you are responsible for your use of the Prize, including complying with all relevant laws and any applicable terms and conditions of use.

## 15 Unclaimed Prize Arrangements

If a Prize is not claimed by the Prize Claim Date or is deemed invalid in accordance with the Entry Restrictions, the Promoter reserves the right (subject to regulatory approval, if required) to sell that prize. Proceeds from such sale will be paid to the Promoter to be used for not-for-profit purposes.

## 16 Additional Terms – Privacy

The Promoter and its authorised marketing partners reserve the right to send marketing communications to any entrant that opts-in to receive communications from the Promoter and its authorised marketing partners. The Promoter and its authorised marketing partners may continue to send communications to the entrant for an indefinite period unless and until advised otherwise by the entrant.

## 17 Additional Terms – Purchasing Tickets

To enter, eligible entrants must, during the Promotion Period, purchase one or more Raffle tickets via the following ways:

1. Visit the Raffle Website and follow the online purchasing process; or
2. Visit one of the personalised WPA or Australian Waterpolo League Club (AWL Club) pages on the Raffle Website and follow the online purchasing process.

For online card transactions, the entrant must use a credit or debit card. Process for Online Transactions:

1. Entrants visit the Raffle Website.
2. If the entrant has followed a link to either the National Teams’ page or a specific AWL Club’s page on the Raffle Website, he/she/they will be directed straight there. If the entrant does not select a specific page link and visits the homepage of the Raffle Website – the entrant will be encouraged to search for and identify a beneficiary AWL Club from a drop-down list of registered AWL Clubs, or to select the National Teams.
3. If the entrant selects an AWL Club, the sale of those tickets will be recorded against that AWL Club. If no AWL Club or National Teams is selected, then the sale will be recorded against the “Anonymous Pool” that will be evenly distributed to all activated participating Clubs at the end of the Promotion Period.
4. Entrant completes all required fields.
5. Payment is processed in real time.
6. Tickets will be sold at \$20 per ticket or 3 tickets for \$55.00, 6 tickets for \$100, or 10 tickets for \$150 plus an online payment processing fee. Note: Discounted tickets are available for bundles. A payment processing fee applies to all credit and debit card sales. This payment processing fee is levied in order to recover the payment processing fees charged by a third-party payment processing

service. The payment processing fee charged by the third-party payment processing service is 1.75% of transaction value plus \$0.30 per ticket per transaction (Transaction Fees).

7. Online payments are deposited from Stripe into the Water Polo Foundation bank account.

8. Water Polo Australia (WPA) reconciles gross payments and remits sums to the relevant Clubs at the end of the Promotion Period (or to the Anonymous Pool for subsequent distribution, if applicable).

The Raffle ticket purchase confirmation will be delivered to the entrant via email. An SMS confirmation can be provided for In Person Sales only (if mobile phone number provided at time of purchase). Confirmation of purchase contains Raffle details including Raffle ticket number(s).

## 18 Prize Restrictions / Exclusions

Any Prize winner and/or participants in a Raffle Prize event may be required to sign an acknowledgement of risk and waiver of liability for participation in the Raffle Prize event and to expressly acknowledge that participation in a Raffle Prize event or Prize may be inherently dangerous, and that if they choose to participate, they will do so at their own risk.

In particular, a reasonable level of health and fitness may be required. The Promoter reserves the right to preclude participation of anyone refusing to sign the acknowledgement/waiver or any person who is suffering from asthma, epilepsy, significant back or neck problems, physical or mental disabilities, or is pregnant or in the Promoter's sole discretion is not able to participate in any of the Prize experiences for their own or anyone's safety.

Prizes and participation in the Prizes are subject to any conditions imposed by the supplier or organiser of the Prizes, as applicable and are subject to any government orders, restrictions or guidelines which may differ in each state. All vouchers and gift cards are subject to the conditions stipulated by the provider of the voucher or gift card including but not limited to applicable dates.

Without limiting any other paragraph in these Terms and Conditions, the Promoter and its associated agencies and companies make no warranties or representations about the fitness for purpose or suitability of the Prize and will not accept responsibility for the quality or fitness for any purpose of any element of the Prize, or the failure of any element of the Prize to be of merchantable quality. If liability under terms implied by legislation cannot be excluded, the liability of the Promoter is the minimum allowable by law.

No Prize is transferable or exchangeable, nor can it be redeemed for cash. If for any reason a winner does not take an element of the Prize at the time stipulated by the Promoter, then that element of the Prize will be forfeited by the winner and cash will not be supplied in lieu of that element of the Prize. The Promoter accepts no responsibility for any variation in Prize value.
