Terms and Conditions**

<b>Promoter</b>	Hawthorn Football Club Limited 3/2 Stadium Circuit Mulgrave VIC 3170 ABN 26 005 068 851
<b>Competition Period</b>	Entries open Monday 2 September 2024 at 10:00am AEST and close Wednesday 25 September 2024 at 4:00pm AEST.
<b>Who can enter?</b>	Entry is open to residents of the <b>Relevant State(s)</b> aged 18 years or older at the commencement of the Raffle. <ul style="list-style-type: none"> <li>• New South Wales (NSW)</li> <li>• Queensland (QLD)</li> <li>• South Australia (SA)</li> <li>• Tasmania (TAS)</li> <li>• Victoria (VIC)</li> </ul>
<b>Who can't enter?</b>	The following people are not eligible to enter and are not eligible for any prizes: <ul style="list-style-type: none"> <li>• Members of the Management Committee from the Organisation conducting the raffle or benefitting from the raffle;</li> <li>• Employees and Contractors of RaffleTix;</li> <li>• Any other person directly engaged in managing the raffle or conducting the draw; or</li> <li>• Any immediate family members of any of the above. Immediate family means a person's spouse (including de-facto spouse), parents, children, and any other family members residing at the same premises as the person.</li> </ul> <p>The following entities are not eligible to enter and are not eligible for any prizes:</p> <ul style="list-style-type: none"> <li>• The Organisation conducting the raffle;</li> <li>• the Organisation benefiting from the raffle.</li> </ul>

<b>How many winners will there be and how will they be chosen?</b>	There will be one (1) winner in respect to this competition.  There will be 1 draw conducted at 3/2 Stadium Circuit Mulgrave VIC 3170 on Wednesday 25 September 2024 at 4:30pm AEST.  The first valid entry drawn randomly from the entries received during the Competition Period will win a prize in accordance with the table in the 'What can I win?' section below.  The Promoter may draw an additional reserve entry in a draw in case a winning entry/entrant is deemed invalid, or a prize is unclaimed (Reserve Entrants).
<b>What can I win?</b>	There is one (1) prize available. The prize is for the winner and one adult companion to attend the 2024 Toyota AFL Grand Final in Melbourne on Saturday 28 September 2024, valued at \$4,790, which includes: <ol style="list-style-type: none"> <li>(a) Two (2) tickets to the 2024 Grand Final Brunch for you and your companion.</li> <li>(b) Two (2) tickets to the 2024 Toyota AFL Grand Final match for you and your companion.</li> </ol> <p>For the avoidance of doubt, travel and accommodation are not included.</p> <p>You and your companion must make your own way to and from the relevant match location, at your own cost (including any costs relating to mandatory quarantine/isolation that may be applicable in your state/territory or a state/territory where the match is hosted).</p>

	<p>All prizes are subject to a pandemic, any travel/government restrictions/directives, border closures, health advice and the like. If the major prize cannot go ahead for the aforementioned reasons, the following may apply:</p> <ul style="list-style-type: none"> <li>• If the match awarded as part of the major prize is moved to another state/territory than originally planned (e.g. the 2024 Toyota AFL Grand Final is moved outside of Victoria), the Promoter will use its best endeavours to honour the tickets for that match (within the restrictions insofar as is permitted), at their discretion.</li> <li>• If you win and cannot take the prize due to travel/government restrictions, you may nominate a friend or family member (18+) to take the prize (and who can take the prize) on your behalf, pending approval from the Promoter.</li> </ul> <p>By accepting or participating in the major prize, your companions accept these Terms and Conditions.</p>

<b>How many times can I enter?</b>	You can enter multiple times and will receive one entry per Qualifying Purchase transaction. Each entry must be submitted separately in accordance with these Terms and Conditions.
<b>How and when will the winner be informed?</b>	The one (1) winner will be notified by telephone and email within two hours of determination and will also have their name and state/territory of residence published at hawthornfc.com.au on 25 September 2024 for a period of 28 days.
<b>Unclaimed prize</b>	<p>Due to the nature of the prize (2024 Grand Final Event on 28 September 2024 ) winners have until 4.30pm on Thursday, 26 September 2024 (you should give them at least 24 hrs to be reasonable) from the date they are notified in which to claim their prize.</p> <p>If the prize has not been accepted or claimed by the prize claim date above or if, after making all reasonable attempts, the Promoter can't contact a winner (or a winner does not contact the Promoter), the relevant entry will be discarded and the Promoter will re-award the relevant prize to Reserve Entrant and/or carry out an unclaimed prize draw at 5pm on 26 September 2024 at the same draw location to randomly distribute the prize.</p> <p>If the winner resides in QLD, the winner will have 12 months from the date they are notified in which to claim their prize. 1. These Terms and Conditions incorporate and must be read together with the details outlined in the table above. Information about prizes and how to enter forms part of these Terms and Conditions. By entering, you accept these Terms and Conditions.
2. Your entry must be received during the Competition Period and will be deemed to be received only when received by the Promoter. If you return a Qualifying Purchase your entry may be deemed invalid at the Promoter's discretion (unless the product

is defective). The Promoter is not liable for any problems with communications networks. You are responsible for your own costs associated with entering. If you enter using automatically generated entries or multiple phone numbers/email addresses/addresses/aliases, you may be disqualified.

3. Prizes and all elements of prizes must be taken as and when offered or will be forfeited, and if forfeited, the Promoter will not be liable. Prizes are subject to any additional terms and conditions imposed by the relevant supplier or the Promoter, including, as relevant:

  - e. any additional fees (payable by you) relating to changes made by you/your companion to a travel/event prize after it has been booked.

  - a. No portion of the major prize is redeemable for cash. The major prize is non-refundable or transferable.
5. You/your companion are responsible for all other unspecified costs related to a prize, including transport etc. Event tickets can only be used once and will be deemed invalid if copied. The Promoter does not control entry to any event location. Winners must keep their tickets safe and the Promoter will not replace lost or stolen tickets.
6. The Promoter is not responsible for any dispute between you and any person with whom you choose to, or choose not to, share a prize.
7. The Promoter accepts no responsibility if one or more of the events or activities awarded as part of a prize are abandoned, called off or postponed for any reason. In that case you/your companion forfeit your entitlement to that event/activity.

10. You must not:
  - a. tamper with the entry process (including but not limited to manipulating the system via bots, script use, or any other means to circumvent the entry process);
  - b. engage in any conduct that may jeopardise the fair and proper conduct of the competition;
  - c. act in a disruptive, annoying, threatening, abusive or harassing manner;
  - d. do anything that may diminish the good name or reputation of the Promoter or any of its related entities or of the agencies or companies associated with this competition;
  - e. breach any law; or
  - f. behave in a way that is otherwise inappropriate.
11. You are responsible for your companion and the Promoter may disqualify all entries from, and prohibit further participation in this competition by, you or your companion if they breach these conditions, whether or not legally bound by them.
12. If you (or your companion, if applicable), in the opinion of the Promoter (and/or a medical professional, as relevant to the circumstances), are intoxicated, under the influence of alcohol or any other drug, behave aggressively or offensively, or behave in a manner which may diminish the good name or reputation of the Promoter or any of its related entities or the agencies or companies associated with this competition, is contrary to law or is otherwise inappropriate, the Promoter may cancel the prize or restrict you (and your companion/s) from participating in any elements of the prize, at its discretion.
13. The Promoter is not liable for entries, prize claims or correspondence that are misplaced, misdirected, delayed, lost, incomplete, illegible or incorrectly submitted.
14. If any dispute arises between you and the Promoter concerning the conduct of this competition or claiming a prize, the Promoter will take reasonable steps to consider your point of view, taking into account any facts or evidence you put forward, and to respond to it fairly within a reasonable time. In all other respects, the Promoter's decision in connection with all aspects of this competition is final.

You agree that if a prize (or element of a prize) is unavailable for any reason the Promoter may provide another item of equal or higher value, subject to any necessary approval by the state/territory gaming authorities.

16. By entering, you request that your full address not be published.
17. Without limiting the previous paragraph, the Promoter and the agencies and companies associated with this competition are not liable for any loss of, damage to or delay in delivery of prize/s, or for any damage that occurs to displayed prize/s (where relevant). Unless otherwise specified, prize/s will only be delivered to addresses in Australia.
