## **TERMS AND CONDITIONS**

## The Flinders Foundation Lottery 2022

- The Lottery is conducted by Flinders Foundation (ABN 66 833 644 600) of 3 Flinders Drive, Bedford Park SA 5042 under license issued by the Government of South Australia, Consumer and Business Services. SA Lottery License number M14256.
- 2. The Lottery is conducted under regulations governing Major Lotteries as published by the Government of South Australia at www.cbs.sa.gov.au/lotteries and in accordance with the Lottery and Gaming Regulations 2008.
- 3. Proceeds benefit Flinders Foundation and will support cancer research, prevention and care at Flinders Medical Centre.
- 4. Entry is open to residents of South Australia, aged 18 years or older.
- 5. Flinders Foundation, its board, staff, members of a management committee and anyone involved in the conduct or promotion of this lottery is ineligible to purchase tickets.
- 6. The Lottery will commence at 12:01am (ACST) on Monday, 1 August 2022 and will end at 10.30pm (ACDT) on Saturday, 15 October 2022.
- 7. Tickets will be sold online only via Raffle Tix at <a href="https://www.raffletix.com.au/flindersfoundationlottery">https://www.raffletix.com.au/flindersfoundationlottery</a>.
- 8. Tickets will be emailed to the purchaser at their nominated email address. In person ticket purchasers will receive their ticket(s) via email if they have provided an email address at the time of purchase. Alternatively, in person orders will receive an SMS with their ticket details.
- 9. On purchasing a ticket in the Lottery, the purchaser agrees to abide by these terms and conditions.
- 10. 3,000 lottery tickets will be available for purchase.
- 11. Tickets will cost \$25 each.
- 12. An electronic draw will be conducted where winners will be randomly selected through a computer-generated process on the RaffleTix platform. First prize will be drawn first followed by all other prizes in descending order.
- 13. The chance of winning a prize is 1 in 428.
