## 1 Raffle Name

## 2 Promoter

The NTI MND Research Raffle 2022 will be conducted by The MND and Me Foundation via its nominee, Jane Milne. The benefitting organisation is The MND and Me Foundation (ABN 34 148 877 141). The benefitting organisation is a not-for-profit organisation.

## 4 Relevant State(s)

New South Wales (NSW), Victoria (VIC) Queensland (QLD), Australian Capital Territory (ACT), South Australia (SA), Tasmania (TAS) and Northern Territory (NT)

Due to government regulations, Western Australian (WA) residents are ineligible to enter.

## 5 Raffle Period

The Promotion starts at 9am AEST on Friday, 1 April 2022. Except in SA, where the promotion will commence at 5pm AEST on Thursday, 7 April 2022.

The Promotion closes at 12pm AEST on Sunday, 10 July 2022. No entries will be accepted after this time.

## 7 Maximum Number of Tickets

35,000 tickets available for purchase at a cost of:

- 1 ticket for \$25 (\$25.00 per ticket)

- 5 tickets for \$100 (\$20.00 per ticket)
- 12 tickets for \$200 (\$16.67 per ticket)
- 20 tickets for \$300 (\$15.00 per ticket)
- 35 tickets for \$500 (\$14.29 per ticket)

The Raffle will close at end of the Promotion Period or when all tickets are sold.

## 8 Maximum Number of Entries

No maximum applies. Participants may purchase as many tickets as they like while the Raffle remains open, and tickets are available.

## 9 Entry Restrictions

Entry is open to residents of New South Wales (NSW), Victoria (VIC) Queensland (QLD), Australian Capital Territory (ACT), South Australia (SA), Tasmania (TAS) and Northern Territory (NT) aged 18 years or older at the commencement of the Raffle period.

Tickets cannot be purchased by any individual involved in the management or organisation of the raffle or the draw. In addition, tickets cannot be purchased by Directors, Management, Committee Members, Staff, or Contractors of The MND and Me Foundation Limited or RaffleTix, or their immediate families, i.e. those living with them.

Draw method: Raffle tickets will be drawn at random from a barrel in the presence of a CPA. First prize will be drawn first.

## 12 Prize Details

### Prize:

One Isuzu 03/2021 model NPS 75/45-155 4X4 Crew Cab Chassis, powered by an Isuzu 4-cylinder turbo diesel engine, automatic transmission, complete with a custom tray body with toolboxes, water tanks and rear stair locker.

Fitted with an Austral Motorhomes Slide On Motorhome Pod, which includes heat pump; air conditioner; heater; bathroom with shower, vanity and toilet with chemical waste tank; kitchen with oven, rangehood, cooktop; lounge/dining setting; total of 4 berths including queen size bed; solar panels with inverter; LED TV; LED lighting.

The vehicle exterior includes rear steps, external lighting, bullbar with driving lights and winch, super singles with alloy wheels, roof and screen guards, rear lift legs on pod and custom vehicle wrap.

The prize includes up to \$10,000 for registration, delivery, 12 months of insurance, 12 months of roadside assistance and as the vehicle requires a special class of licence to drive, NTI will contribute \$500 for the raffle winner to obtain the correct license (if required) to drive this vehicle.
