1 Raffle Name

AA80 Fundraising Raffle

2 Promoter

AA80 Raffle will be conducted by the General Service Board of Alcoholics Anonymous T/A National Convention 1, ABN: 77 001 417 125, of 1/1 Garnet St, Rockdale NSW, 2216. The benefiting organisation is the General Service Board of Alcoholics Anonymous Australia, a not-for-profit organisation.

4 Relevant State(s)

Permitted

Entry is open to residents of the following State(s) aged 18 years or older at the commencement of the Raffle:

- New South Wales (NSW)
- Queensland (QLD) Limited to raising a maximum revenue of \$50k in QLD
- South Australia (SA) To be opened in SA pending permit approval
- Victoria (VIC)

Not Permitted

Residents of the following States are **NOT PERMITTED** to purchase tickets in the raffle and are not eligible for any prizes:

- Australian Capital Territory (ACT)
- Northern Territory (NT)
- Tasmania (TAS)
- Western Australia (WA)



5 Raffle Period

The Promotion starts at 9am AEDT on 29 March 2024.

The Promotion closes at 4pm AEDT on 18 November 2024. No entries will be accepted after this time.

7 Maximum Number of Tickets

8 Maximum Number of Entries

No maximum applies. Participants may purchase as many tickets as they like while the Raffle remains open, and tickets are available.

9 Entry Restrictions

Entry is open to residents of the **Relevant State(s)** aged 18 years or older at the commencement of the Raffle.

The following people are not eligible to enter and are not eligible for any prizes:

- Members of the Management Committee from the Organisation conducting the raffle or benefitting from the raffle;
- Employees and Contractors of RaffleTix;
- Any other person directly engaged in managing the raffle or conducting the draw; or
- Any immediate family members of any of the above. Immediate family means a person's spouse (including de-facto spouse), parents, children, and any other family members residing at the same premises as the person.

The following entities are not eligible to enter and are not eligible for any prizes:

• The Organisation conducting the raffle;



• the Organisation benefiting from the raffle.

10 Verification Requirements

If requested by the Promoter, a person drawn as the winner of a prize must produce proof of age and residency prior to being awarded a prize. Due to the nature of the prize (a travel prize for specific dates), winners have six (6) months from the date they are notified in which to claim their prize.

16 Unclaimed Prize Arrangements

If a Prize is not claimed by the Prize Claim Date or is deemed invalid in accordance with the Entry Restrictions, the Promoter reserves the right (subject to regulatory approval, if required) to sell that prize.
