Raffle overview

The Raffle will take place in accordance with the *Gaming and Wagering Commission Act 1987* (WA) and any other relevant legislative requirements.

The Raffle will be conducted by the Promoter.

The raffle:

- opens at 10:00 am AWST on Tuesday 15 August 2023 (the **Commencement Date**);
- closes at 9:00 pm AWST on Tuesday 14 November 2023. No entries will be accepted after this time; and
- is to raise funds for research and support services to support people in WA living with cystic fibrosis and their families.

(the **Raffle**).

Total number of tickets available and purchasing

A total of 1,100 tickets will be available for purchase at \$250 each.

Draw details

The Draw will take place at 10:00 am AWST on Thursday 16 November 2023 (the **Drawing Date**) at Cystic Fibrosis WA office at The Niche, Suite C, 11 Aberdare Road, Nedlands, Western Australia 6009.

Draw method

The Draw will be conducted electronically. The first ticket drawn will be awarded the first prize, and the second ticket drawn will be awarded the second prize.
