1 Raffle Name

2 Promoter

8 Maximum Number of Entries

9 Entry Restrictions

Entry is open to residents of NSW, VIC, TAS and NT, aged 18 years or older at the commencement of the Raffle.

Directors, management, employees, contactors (or members of their immediate family) of the Promoter or the Promoter's related entities or any of the Promoter's agents, including RaffleTix, (as determined by the Promoter) are not eligible to enter.
