### **1. GENERAL TERMS AND CONDITIONS**

- 1.2. Information on how to enter and prizes form part of these terms and conditions. By participating, entrants agree to be bound by these terms and conditions and warrant they are not prohibited from accepting a prize. 1 Million Women reserves the right to disqualify entries for noncompliance with these terms and conditions.

### **2. ENTRY**

- 2.1. Raffle ticket sales will commence on 14/10/2021 and will conclude on 21/12/2021 at 11:59 pm Australian Eastern Standard Time or when tickets are sold out.
- 2.2. There are 20,000 tickets available. Entrants are not restricted or limited to the number of raffle tickets which may be purchased.
- 2.3. Each single ticket is priced at AUD \$10.00.
- 2.4. All raffle tickets will be sold online at <https://www.raffletix.com.au/1millionwomenraffle>. Employees and their immediate family members of any company associated with the raffle are ineligible to enter. Entrants will need to enter their personal details in the sections. Incomplete or incomprehensible entries will be ineligible. Complete entries will include a first and last name, a full address and a contact telephone number and email address, at a minimum.
- 2.5. All tickets purchased will be in the entrant's name and cannot be on-sold.
- 2.6. The legal age for purchasing raffle tickets is 18 years.

### **3. DRAW AND PRIZE**

- 3.1. The raffle will be drawn by 1 Million Women at 12pm Australian Eastern Standard Time on 23/12/2021 at 20-40 Meagher street, Chippendale, 2008, NSW.
- 3.2. The first valid entry to be drawn will win the prize. There is 1 prize available. Prize consists of 1x Nissan LEAF 40 kWh 5-door hatch in Arctic White exterior paint, valued at \$53,190.00 drive-away, including 12 months registration, 12 months compulsory third party insurance, dealer delivery charge and stamp duty as at October.
- 3.3. Prize includes on-road costs (12 months' registration, 12 months' compulsory third party insurance, a maximum dealer delivery charge and stamp duty).
