Name

Promotion Period

1. Opening date of ticket sales: 17/06/23 at 7am AEST
2. Closing date of ticket sales: 28/07/23 at 12am (midnight) AEST
3. No entries will be accepted after 12.00am (midnight) AEST on the closing date 28/7/23

Draw

1. The Levi's Project Raffle will be drawn at 8:00am AEST on 29/07/23 at 133 Gannons Road, Caringbah South, NSW, 2229.

Draw Method

1. An electronic draw will be conducted. First prize will be drawn first followed by all other prizes in descending order (for a complete list of prizes see the Schedule of Prizes below).

Entry
