## WHO CAN ENTER?

- Entry is open to all permanent residents of NSW over the age of 18. That are of an age that are able to obtain their full unrestricted driver's license and register the car in their name can enter.
- Members of the association and organizing committee associated with this raffle, and their immediate families, are ineligible to purchase raffle tickets. *Immediate families* means a person's spouse and family members residing at the same premises as the person associated as per the above.
