Competition Period	Entries open Wednesday 27 August 2025 at 10:00am AEST and close Wednesday 24 September 2025 at 4:00pm AEST.
Who can enter?	Entry is open to residents of the Relevant State(s) aged 18 years or older at the commencement of the Raffle: <ul style="list-style-type: none"> • New South Wales (NSW) • Queensland (QLD) • Tasmania (TAS) • Victoria (VIC)
Who can't enter?	The following people are not eligible to enter and are not eligible for any prizes: <ul style="list-style-type: none"> • Members of the Management Committee from the Promoter conducting the Raffle or benefitting from the Raffle; • Employees and Contractors of RaffleTix; • Any other person directly engaged in managing the Raffle or conducting the Draw; or • Any immediate family members of any of the above. Immediate family means a person's spouse (including de-facto spouse), parents, children, and any other family members residing at the same premises as the person. <p>The following entities are not eligible to enter and are not eligible for any prizes:</p> <ul style="list-style-type: none"> • The Promoter conducting the Raffle; • the Promoter benefitting from the Raffle.

How many winners will there be and how will they be chosen?	There will be one (1) winner in respect to this competition. There will be 1 draw conducted at 3/2 Stadium Circuit Mulgrave VIC 3170 on Wednesday 24 September 2025 at 4:30pm AEST. The Promoter may draw an additional reserve entry in a draw in case a winning entry/entrant is deemed invalid, or a prize is unclaimed (Reserve Entrants).

(b) Two (2) reserved seat tickets to the 2025 Toyota AFL Grand Final for you and your companion. <p>For the avoidance of doubt, travel and accommodation are not included.</p> <p>You and your companion must make your own way to and from the relevant match location, at your own cost (including any costs relating to mandatory quarantine/isolation that may be applicable in your state/territory or a state/territory where the match is hosted).</p> <p>All prizes are subject to a pandemic, any travel/government restrictions/directives, border closures, health advice and the like. How and when will the winner be informed?	The one (1) winner will be notified by telephone and email within two hours of determination and will also have their name and state/territory of residence published at hawthornfc.com.au on Thursday 25 September 2025 for a period of 28 days.
Unclaimed prize	<p>Due to the nature of the prize (2025 Grand Final Event on Saturday 27 September 2025) winners have until 4.30pm on Thursday 25 September 2025 (you should give them at least 24 hours to be reasonable) from the date they are notified in which to claim their prize.</p> <p>If the prize has not been accepted or claimed by the prize claim date above or if, after making all reasonable attempts, the Promoter can't contact a winner (or a winner does not contact the Promoter), the relevant entry will be discarded and the Promoter will re-award the relevant prize to Reserve Entrant and/or carry out an unclaimed prize draw at 5pm on Thursday 25 September 2025 at the same draw location to randomly distribute the prize.</p> <p>If the winner resides in QLD, the winner will have 12 months from the date they are notified in which to claim their prize. 1. These Terms and Conditions incorporate and must be read together with the details outlined in the table above. Information about prizes and how to enter forms part of these Terms and Conditions. By entering, you accept these Terms and Conditions.
2. Your entry must be received during the Competition Period and will be deemed to be received only when received by the Promoter. If you return a Qualifying Purchase your entry may be deemed invalid at the Promoter's discretion (unless the product is defective). The Promoter is not liable for any problems with communications networks. You are responsible for your own costs associated with entering. If you enter using automatically generated entries or multiple phone numbers/email addresses/addresses/aliases, you may be disqualified.

 - e. breach any law; or

 11. You are responsible for your companion and the Promoter may disqualify all entries from, and prohibit further participation in this competition by, you or your companion if they breach these conditions, whether or not legally bound by them.

If you (or your companion, if applicable), in the opinion of the Promoter (and/or a medical professional, as relevant to the circumstances), are intoxicated, under the influence of alcohol or any other drug, behave aggressively or offensively, or behave in a manner which may diminish the good name or reputation of the Promoter or any of its related entities or the agencies or companies associated with this competition, is contrary to law or is otherwise inappropriate, the Promoter may cancel the prize or restrict you (and your companion/s) from participating in any elements of the prize, at its discretion.
