5 Raffle Period

The Promotion starts at 6 am (AEST) on Friday, 27 August 2021.

The Promotion closes at 11 pm (AEDT) on Monday, 20th December 2021. No entries will be accepted after this time.

7 Maximum Number of Tickets

5,800 tickets available for purchase at \$25 each.

8 Entry Restrictions

Entry is open to residents of New South Wales, Victoria, Australian Capital Territory, Queensland, South Australia, Western Australia, Tasmania and Northern Territory aged 18 years or older.

Directors, management, employees, contactors (or members of their immediate family) of the Promoter or the Promoter's related entities or any of the Promoter's agents, including RaffleTix and Raise for Good, directly involved in the organisation of the Raffle (as determined by the Promoter) are not eligible to enter.
