

## Art Union Terms and Conditions

### 1. Art Union Raffle and Prizes

---

- a) The Rotary Club of Townsville Sunrise Inc. (RCoTS) Art Union Raffle (AUR) is conducted as a Category 3 Art Union under the Queensland Office of Liquor and Gaming Regulations, NSW Gaming Regulations, VIC Gambling Regulations.
- (a) First Prize –
- (i) A Ford Ranger Wildtrak to a value of approximately \$85,000.00\* (\*Value inclusive of freight to any Ford Dealership in QLD, NSW, VIC). Including insurance and registration. Delivery timeframes from manufacturer may apply.
- (ii) An SUV Teletrack Camper with Deluxe Pack and XL Pack valued at approximately \$40,000\*\* (Camper and all inclusions at retail value) (\*\*Value inclusive of freight to an agreed address in Townsville, Brisbane, Sydney and Melbourne). Including insurance and registration. Delivery timeframes from manufacturer may apply.
- (b) Second Prize – A voucher or the like from a named supplier to a value of \$10,000.00, with an expiry date of 36 months from the draw date.
- (c) Third Prize – a voucher or the like from a named supplier to the value of \$5,000.00, with an expiry date of 36 months from the draw date.

The value in the case of each prize will be the retail value according to the supplier of the prize.

### 2. Tickets

---

- a) A maximum number of 7,000 tickets will be sold at \$50 each with the following discount structure for multiples of tickets purchased in one transaction:

*Ticket Prices
1 for the price of \$50
2 for the price of \$100
3 for the price of \$150
5 for the price of \$200
15 for the price of \$500
30 for the price of \$900

- b) Tickets are available for purchase online or in person from a RCoTS representative or external seller. All ticket purchases require immediate payment.
- c) Tickets will be issued upon receipt of payment.
- d) Tickets cannot be purchased by a member of the Art Union Raffle Committee, including any individual involved in the organisation of the raffle or the draw (including RaffleTix). In addition, tickets cannot be purchased by the association conducting or benefiting from the raffle, or its Management Committee (whether a voting member or not) including immediate family members\*.

\*Immediate family means a person's relatives (including defacto spouse), parent, child or sibling (whether of full or half blood) and any other family members living with them.

### **3. Closing Date, Draw and Notification**

---

- a) The close date is 9am (AEST), 12 October 2024.
- b) The draw date is 11am (AEST), 12 October 2024 at a public draw to be held at the Carmichael Ford, 77 Charters Towers Road, Hyde Park, Queensland.
- c) If the AURC decides that an insufficient number of tickets will be sold by the closing date, the closing date and the drawing date may both be extended (with the required approvals from the relevant regulators) such that the drawing date is not later than one (1) year after the day tickets in the AUR start to be sold.
- d) The results of the AUR will be published on our website [Townsvillesunriserotary.org.au](http://Townsvillesunriserotary.org.au) and in the Townsville Bulletin on the date specified (unless extended) in the tickets detailing the prizes won, the names of the prize winners and the winning ticket numbers. Winners will be notified by Phone and Registered Mail.
- e) The AURC will make all reasonable efforts in accordance with the relevant Gaming Act in which state the ticket was purchased to notify the winner by telephone, and/or registered mail.
- f) If a prize winner does not claim their prize within thirty six (36) months of the draw, then the prize will be deemed abandoned and entitlement to the prize, if by then having been purchased by the Club, will remain with the Club, but if not so purchased, the Club will be under no obligation to do so. The Club is not liable to conduct a redraw for any prize that is not claimed by a prize winner within thirty six (36) months of the draw.

### **4. Other**

---

- a) Any other expenses, including but not limited to transport and other costs involved in the collection of the prize (other than when specifically included in the prize) are at the winner's sole expense.
- b) None of the prizes offered may be substituted for cash.
- c) All proceeds of the AUR are for the purpose of funding Rotary projects and programs at the sole discretion of the RCoTS.
- d) Photographs are used for illustration purposes only. They are not to scale and are not an accurate presentation of the prize.
- e) While conducting this AUR, The RCoTS collects your personal information. It reserves the right to use this information for future marketing purposes and to fulfil your ticketing orders.
