1 Raffle Name

2 Promoter

Not Permitted

- Australian Capital Territory (ACT)
- Northern Territory (NT)
- South Australia (SA)
- Tasmania (TAS)
- Victoria (VIC)
- Western Australia (WA)

5 Raffle Period

The Promotion closes at 7.15am AEST on Wednesday 28th August 2024. No entries will be accepted after this time.

7 Maximum Number of Tickets

8 Maximum Number of Entries

No maximum applies. Participants may purchase as many tickets as they like while the Raffle remains open, and tickets are available.

9 Entry Restrictions

Entry is open to residents of the **Relevant State(s)** aged 18 years or older at the commencement of the Raffle.

The following people are not eligible to enter and are not eligible for any prizes:

1. The current President, Vice President, Secretary and Treasurer of the St Rita's College Parents and Friends Association,
2. A person directly engaged in organising the raffle or conducting the draw,
3. A member of the St Rita's College Board of Directors
4. A member of the St Rita's Leadership Team

10 Verification Requirements

If requested by the Promoter, a person drawn as the winner of a prize must produce proof of age and residency prior to being awarded a prize.
