# 1 Raffle Name

# 2 Promoter

# 3 Relevant State(s)

The raffle is open to residents of Queensland.

### 4 Raffle Period

The Promotion starts at 2pm AEST Friday, 3 June 2022.

The Promotion closes at 2pm AEST, Friday 1st July 2022. No entries will be accepted after this time.

### 6 Maximum Number of Tickets

2500 tickets available for purchase at \$20 each.

The Raffle will close at end of the Raffle Period or when all tickets are sold.

## 7 Maximum Number of Entries

# 8 Entry Restrictions

Entry is open to residents of Queensland aged 18 years or older at the commencement of the Raffle.

# 9 Verification Requirements
