Entry Restriction(s)	Entry is open to residents of Queensland, New South Wales, aged 18 years or older at the commencement of the Raffle. Tickets cannot be purchased by any individual involved in the organisation of the raffle or the draw (including RaffleTix). In addition, tickets cannot be purchased by the association conducting or benefiting from the raffle, or Women’s Legal Service Qld Board Members or Management, including immediate family members* *Immediate Family - means a person’s spouse and family members residing at the same premises as the person.
